CONSENT FOR EMERGENCY TREATMENT FOR INTERSCHOLASTIC ACTIVITY INJURIES I, (we), parent(s) or guardian(s) of the student named above in consideration of my son's/daughter's opportunity to participate in interscholastic activities, hereby consent to emergency medical treatment, in the event of injury or illness during all periods of time in which the student is away from his/her legal residence as a member of an interscholastic activity team or group. I hereby waive on behalf of myself, my spouse (if applicable) and the above named student any liability of School District Twenty, its agents or employees arising out of such medical treatment.

## DRUG, ALCOHOL AND TOBACCO POLICY

As a participant of athletics at Air Academy High School, the student-athlete will not use or be in possession of alcohol, drugs, or tobacco (in any form), and will not attend functions on or off school grounds where alcohol and/or drugs are present during any part of the school year. This requirement for student athletes does not preclude religious activities or special functions for the family (Colorado Law 18-13-122). Should the student-athlete violate any of the above, the following process will be followed:

## NO Self Report

<u>1<sup>st</sup> Offense</u>

• The student athlete will be ineligible for the remainder of the season and up to 365 days.

• An eligibility committee comprised of the athletic director, grade level administrator, and athletic coach will review the details of the situation and determine the length of the suspension from participation.

- On a <u>first offense only</u>, the athlete may meet with the eligibility committee and agree to a contract to regain eligibility. This contract typically includes an agreement for the athlete to complete an approved drug/alcohol assessment program.
- If the athlete successfully completes the requirements of the contract, he/she may return to the team after suspension of 30% of the total season. This length of suspension may be carried forward into the following season of participation.

**SELF REPORT:** Student athletes will be encouraged to self-report any drug, alcohol, or tobacco use or possession. A student who self-reports is demonstrating knowledge of wrongdoing and a desire to correct the problem, thus he/she will earn additional consideration in determination of consequences. The self-report must occur within 3 calendar days of the infraction. This opportunity for reduced consequences for self-reporting is available ONLY for a first offense. <u>1st Offense -</u>

The eligibility committee may reduce the penalty to 20% of suspension from contests if a student self-reports. This length of suspension may be carried forward into the following season of participation if the violation of this agreement occurs too close to the end of a season for an athlete to serve the consequences. **2nd Offense** -

A student athlete will be ineligible for 365 calendar days from the date of the infraction in all sports and sport activities offered at AAHS. <u>3rd Offense -</u>

A student athlete will be permanently ineligible for all sport and sport activities for the remainder of their Air Academy High School career.

Distribution of drugs or alcohol is considered the most serious violation of the AAHS drug and alcohol policy. An athlete who is suspended or expelled for distribution will be ineligible for athletic participation for 365 days from the date of the suspension.
